The Honorable M. Joseph Manning Award for Community Service

Legacy of Service

Each year, the East Milton Neighborhood Association (EMNA) honors the legacy of the Honorable M. Joseph Manning with the M. Joseph Manning Community Service Award.

The Honorable M. Joseph Manning dedicated much of his life to public service and enhancing the lives of Milton residents. For 30 years, from 1966 to 1996, Mr. Manning served as a State Representative from for the 7th Norfolk District in Milton and Randolph. He was a member of the Massachusetts Legislators Association; Massachusetts Assessors Association; Milton Town Meeting Member; former member of the Milton Board of Assessors; Milton Park Commission; Milton Yacht Club; American Legion Post #114; Randolph Elks; Milton Kiwanis; DAV and Amvets in Randolph; and was a Marine Corp Veteran of World War II.

About the M. Joseph Manning Community Service Award

The annual M. Joseph Manning Community Service Award is the EMNA's most prestigious community award. It recognizes Milton residents who share their talent and skills to enrich our community. Only one Milton resident per year (or couples/partners performing services together) can receive the Award.

- Couples or partners who perform service together are also eligible; however, teams are not eligible.
- In special circumstances the award may be given posthumously.

EMNA Vision and Mission

Recipient Selection Process

EMNA Executive Board will convene a Selection Committee to ensure diverse perspectives and to review all nominations. The selection of the recipient is at the sole discretion of the EMNA Executive Board.
